Funding

15hrs Universal Funding for all children aged 3 & 4 yrs

The term after a child turns 3yrs entitles them to receive 15hrs of free early years education. We are able to offer funded places for 3 and 4 yrs-old children and parents have the flexible option to choose 15hrs from the any of our sessions (as detailed below).

Additional 15hrs Funding for Working Parents of children aged 3 & 4 yrs

For working parents of 3 and 4-year-old children, parents can claim a further 15hrs of funded childcare from Kerswell Preschool or split care with another childcare setting. Parents have the flexible option to choose hours from any of our sessions (as detailed below). Applications for funding should be made via <https://www.childcarechoices.gov.uk> and **places will only be offered once we have verified the funding code issued by HMRC**

Funding for Disadvantaged 2yrs-olds

Some two-year-olds are entitled to 15hrs of free early education and childcare, families are usually informed by their local authority the term prior to the child's 2nd birthday if they are eligible and will receive a funding code which they must give to us prior to a place being offered, sessions can only be selected from our main sessions. Upto 30hrs Funding for Working Parents of children aged 2yrs

For working parents of 2-year-old children, parents can claim up to 30hrs funded childcare from Kerswell Preschool, parents have the flexible option to choose hours from any of our sessions (as detailed below). Applications for funding should be made via <https://www.childcarechoices.gov.uk> and **places will only be offered once we have verified the funding code issued by HMRC**

The awarding of all Early Years Funding is dependent on parent/guardians completing a Parent Declaration Form, we require a copy of your child's birth certificate

Kerswell Kids Preschool are not responsible for renewing eligibility codes, parents that loose funding are liable to meet the full cost of unfunded sessions
